

Parking Lots

- Use of the parking lots is limited to patrons in possession of a seasonal or weekly parking pass.
- Seasonal and weekly passes are available only to MFD residents and property owners. Passes will be available to purchase at the Moderator's office at 10 Winnapaug Rd. and at the fire station on the following weekends: May 20-21, May 27-28 and June 3-4 from 9:00-1:00.
- Unauthorized vehicles will be towed at owner's expense.
- Cars remaining in parking lots after 6:00pm will be towed at owner's expense. Repeat violations will result in the forfeiture of parking pass.
- Misuse and/or forgery of passes will result in forfeiture of beach privileges.
- Parking passes should be hung from rear view mirror and be clearly visible to beach attendants.

Garbage Pickup

Garbage Pickup Schedule:

Year round for the entire District is on Wednesdays. Summer Saturday Pickup begins on the 3rd Saturday in June and ends on the 2nd Saturday of September.

- All trash must be placed in Town of Westerly orange bags and contained in proper garbage receptacles.
- All recyclables must be in a separate container. Recyclables can be co-mingled (paper, glass, plastic and cans).
- Trash should be ready for pickup by 7:00am on scheduled pickup day.
- **Do not** place garbage at the curb, collection will occur at the house.

Our Beaches

Operating Hours:

Weekdays 10:00am-6:00pm

Weekends 9:00am-6:00pm

Holidays 9:00am-6:00pm

- Clark Farms, Benson and Lawton beaches are private MFD properties for use by the residents, property owners and their guests.
- All patrons must be in possession of a beach pass or hotel pass to gain access to MFD property. Pass must be visible at all times. **Passes, both parking and walk on, will be required on opening day.**
- Be respectful and neat in the use of the bathroom facilities.
- Please remove all trash when leaving beaches and place in designated receptacles. Please recycle!
- Please be aware, beaches are cleaned daily. Do not drop off chairs and towels before opening time as they may be damaged for cleanup.
- Please keep off the fenced off area of the dunes as restoration is in progress.

Rules & Regulations

- No animals at any time.
- No surf boarding, skim boarding, ball playing, Frisbee throwing, or any other activity that may endanger beach patrons. Small plastic boards (Boogie boards) used for body surfing are allowed at Lifeguard's discretion.
- No alcoholic beverages or drugs; violators will be asked to leave MFD property and are also subject to arrest by Westerly PD. Management has the right to inspect cooler contents.
- No glass containers on the beach.
- No smoking on the beach (this includes electronic cigarettes).
- No hole can be deeper than 2 feet. Holes must be filled in and sand castles taken down before patrons leave the beach.
- No tents or canopies are allowed. Small "igloos" used for protections of infants are allowed only along the fence line.
- No fires or fireworks permitted at any time.
- All music must be played only through earphones or personal listening devices.
- No fishing allowed during beach hours.

Lifeguards

- Instructions of lifeguards and other MFD employees must be obeyed.
- All injuries should be reported to the nearest lifeguard immediately.
- A missing person should be reported to the nearest lifeguard immediately.
- MFD recommends that patrons swim only when the lifeguards are on duty.
- No sitting in front of lifeguard stations; a clear path to the water must be maintained.
- No lifeguards or attendants will be on duty after 6:00pm and swimming will be at your own risk.
